

EAA Exam Information

April/May & September/October 2025

The exams for *Actuarial Data Science* are organised and carried out by the EAA – European Actuarial Academy GmbH for all participants who are not members of the Aktuarvereinigung Österreichs e.V. (AVÖ) or the Deutsche Aktuarvereinigung e.V. (DAV). For members of AVÖ and DAV, the exams are organised by DAV.

The exams in presence as well as the practical tests will be in English or German language by your choice in answering in German or English language (both question sheets are being provided).

The exams in presence are scheduled as follows:

- Friday, 23 May 2025, 14.00-17.00 o'clock (CEST):
Exam in presence for the module Actuarial Data Science Basic
- Friday, 24 October 2025, 14.00-17.00 o'clock (CEST):
Exam in presence for the module Actuarial Data Science Advanced.

The exams in presence of the EAA take place in the FAM-Library of the TU Wien, Wiedner Hauptstr. 8-10, 1040 Vienna, Austria.

The practical tests are scheduled as follows:

- 13 April till 13 May 2025
Practical Test for the module Actuarial Data Science Immersion
Creation and upload of a project work in the form of a Jupyter notebook or an R Markdown document, upload 12.05. 00:05 o'clock till 13.05. 23:55 o'clock.
Compulsory test process 10.04. 12:00 o'clock till 12.04. 18:00 o'clock. The question sheet can be downloaded at 13.04. from 00:05 o'clock till 23:55 o'clock. All Times: CEST.
- 14 September till 14 October 2025
Practical Test for the module Actuarial Data Science Completion
Creation and upload of a project work in the form of a Jupyter notebook or an R Markdown document, upload 13.10. 00:05 o'clock till 14.10. 23:55 o'clock.
Compulsory test process 11.09. 12:00 o'clock till 13.09. 18:00 o'clock. The question sheet can be downloaded at 14.09. from 00:05 o'clock till 23:55 o'clock. All Times: CEST.

The fee for each exam for attendees who are not a member of DAV or AVÖ and who have a non-company billing address is € 498.00 (incl. 20% VAT).

The fee for each exam for attendees who are not a member of DAV or AVÖ and who have an EU company billing address (excluding German company billing address) is € 415.00 net (reverse charge).

The exam fee includes participation. Accommodation and catering are not included.

Registration deadline for the exams in presence is Friday four weeks in advance of the start of the relevant exam, which is 25 April 2025, by the end of the day, for the exam in presence in May, and 26 September 2025, by the end of the day, for the exam in presence in October.

Registration deadline for the practical tests is Wednesday of the first week of the test which is 9 April 2025, by the end of the day, for the test in April/May, and 10 September 2025, by the end of the day, for the test in September/October.

No responsibility is taken for the accuracy of this information.

Members of AVÖ or DAV: We kindly ask all members of AVÖ and DAV to register via the DAV website www.aktuar.de for the CADS exams. The CADS exams are organised by the DAV. For your first exam registration as a member of the AVÖ, please provide a certificate confirming that you are a full member of the AVÖ. Otherwise, you will not be admitted to participate in the exam.
