Please send your submission for a presentation at the **EAA e-Conference on 'Data Science & Data Ethics'** including an abstract (approx. half a page) and a short CV of the presenter(s) to submissions@actuarial-academy.com. Please use this [Word template](#) for your submission.

Presentations should provide an in-depth look at experiences, research findings, case studies, solutions, or future trends. Please state clearly why your contribution will arouse sufficient interest among the conference delegates. Your presentation time at the conference will be 30 minutes. The language of the e-Conference will be English.

Submission deadline: 20 January 2026.

Thereafter, the programme will be created, and applicants will receive feedback.

Estimated programme publication date: 10 February 2026.

Accepted speakers will benefit from a **fee-free participation** at the e-Conference. This offer extends to a maximum of two speakers per presentation slot.
